COMMITTEE/COUNCIL REPORTS:

Councilwoman Hodges stated that the paving of Union Avenue and Pine Street will begin next week. Mrs. Hodges also stated that a prototype of a bench to stop the sand on the beach from blowing, is set up adding that it's not pretty but it could work. Mrs. Hodges went on to say that it is an answer but not the answer. Mrs. Hodges also said that the seed should be in soon and that they will be seeding where the bulkhead was put in.

Councilwoman Dugan reported that the introduction of the budget should be at the May 2nd meeting. Mrs. Dugan went on to say that student enrollment is up at the school, and they have 420 children enrolled. Mrs. Dugan noted that every child in the school will get free breakfast and lunch next year. Mrs. Dugan stated the school budget meeting will be on April 29th and that Lakehurst Elementary School received \$900,000.00 in school aid when most districts were cut. Mrs. Dugan also went on to wish Councilman Davis a happy birthday.

Councilman McCarthy stated that he would like to commend the Public Works Department on the genuine effort going into Fuccile Park. Mr. McCarthy also stated that they are striking out on lifeguards so if anyone knows someone, please send them our way. Mr. McCarthy went on to say the Public Works will park a dump truck at the Police Station for me to drive during the cleanup event.

Councilman Oglesby said the Personnel Department is working on creating a HR position. Mr. Oglesby stated that several things that are being done now should be handled by HR.

Oglesby also stated that the department heads also draw up a five-year plan with their budget.

Mr. Margeson questioned if the Borough was responsible for the fire trucks.

Councilman Oglesby stated that the town actually owns the fire trucks.
