Councilman Oglesby requested that a memo be sent to emergency responders concerning the newly enacted statute signed into effect on August 7, 2012 by Governor Christie which makes photographing or otherwise recording of accident victims a disorderly person's offense.

Councilman Lowe reported that he will require a copy of the map of the proposed firing range in order to determine the size of the property available for a solar farm.

Councilman McComas reported that there has been a delay in mobilization for the 500,000 groundwater storage tank repainting project. Mr. McComas stated that the delay has raised a concern about the potential for cold weather.

Councilman Oglesby reported that Public Works Supervisor/Department Head David Winton has submitted a lake lowering permit in an attempt to hinder some of the growth of vegetation in Lake Horicon. Mr. Oglesby added that it is hoped that a cold winter will freeze the roots of the vegetation.

Councilman Seaman suggested that the cedar pilings located on second beach be removed during the lowering process for possible use at first beach.
