VFW POPPY PRINCESS PRESENT TO KICK-OFF ANNUAL "BUDDY POPPY" SALES:

Poppy Princess Madison Jones kicked-off the annual "Buddy Poppy" sales after which VFW Post 10061 Commander Harry Young presented a proclamation.

**REVIEW OF REGULAR MEETING AGENDA:** 

Municipal Clerk Capasso reviewed the regular meeting agenda.

Council President Oglesby reported that Sunday's storm left an exorbitant amount of sand loss at Lake Horicon. Mr. Oglesby stated that the borough has explored this problem in the past and found that heavier sand is costly but maybe benches with lattice underneath could be placed along the beach. Mr. Oglesby went on to say that the cost of a heavy sand can be no more than what the borough is spending to replenish the sand and manpower, asking the borough to reexamine the costs.

Mayor Robbins confirmed the handicap ramp is unrecognizable after he viewed photos that Mr. Oglesby had presented.

Mr. Oglesby further stated that the storm drain is covered as well, adding he does not have a "concrete" solution; however, something needs to be done.

Councilman McCarthy suggested an elevated boardwalk along the beach.

Mayor Robbins stated that he will reach out to Public Works Department Head Dave Winton to discuss a possible boardwalk.

Mr. Oglesby commended all responders, both paid and volunteers, for those that came from out of town and in town, for their outstanding job extinguishing the wildfire.

Mayor Robbins echoed Mr. Oglesby.

Councilwoman Dugan announced today is International Firefighter Day and thanked all firefighters for saving the borough.

Councilman McCarthy reported the signs for Lake Horicon have arrived and will be installed next week.

Bruce Margeson, 5 Geneva Road, asked if the two hired police officers will be armed.

Mayor Robbins answered in the affirmative.

Mr. Margeson stated that \$18 dollars an hour is an inadequate amount for the environment today, risking their lives.

Councilman McCarthy responded the amount is a common number for a Class II Officer in this area adding a Class II Officer typically works the boardwalk at the shore and are "inspiring" to be a full-time police officer.

Mr. Margeson stated \$18 dollars is just a small amount over minimum wage. Mr. Margeson went on to say \$20 an hour is just a few dollars more and more reasonable, adding Seaside Heights and Seaside Park is more than likely paying a higher wage.

Mayor Robbins responded unfortunately both Seaside Heights and Seaside Park have a higher revenue than Lakehurst.

Bruce Margeson, 5 Geneva Road, stated he had expressed in the past the need for rent control and was told that the borough would need a Housing Authority to do so. Mr. Margeson asked would it be possible to have a Housing Authority under the umbrella of the Municipal Housing Liaison; therefore, the borough can control the rent for senior citizens and low-income families.

Mayor Robbins responded that the ordinance committee can revisit the ordinance.

Mr. Margeson stated the borough has a Chicken Committee.

Council President Oglesby added the Chicken Committee's primary focus was to create a Chicken Ordinance to be fair and proper for the residents and once it was established, the committee was to meet if need be.

Mr. Margeson suggested the borough create a Housing Authority position for the protection of the residents.

Bruce Margeson, 5 Geneva Road, thanked the Mayor and Council for all the hard work that was put into creating the budget, adding it is not a simple thing to accomplish.

Mayor Robbins thanked the borough's Chief Financial Officer, Wayne Sibilia, for making the budget work for the borough.

### COMMITTEE/COUNCIL REPORTS:

Councilwoman Hodges reported the Public Works Committee met with Public Works Department Head Dave Winton. Mrs. Hodges stated the first item of discussion was the interest of two Public Works employees receiving their CDL license. Mrs. Hodges also stated that the state now requires training before receiving a CDL license and added Mr. Winton is able to become a trainer so that training can be completed "in-house".

Mayor Robbins replied that he did not realize that training was required, adding he will reach out to Mr. Winton in regard to the training.

Mrs. Hodges stated that the leak detection study resolved 50% of the water loss issue and added that the system is old which could account for the other 50%. Mrs. Hodges also stated that the dump body has been installed on the 2006 Ford F-550 and the new ice machine has been installed at the community center. Mrs. Hodges further stated that Mr. Winton received the "No Smoking" signs and is waiting for directions from Police Chief

Kline as to where they are to be placed. Mrs. Hodges went on to say that Mr. Winton is obtaining quotes for generator maintenance.

Mayor Robbins stated that he knows of a few companies that perform generator maintenance and will reach out to Mr. Winton.

Mrs. Hodges also reported that Mr. Winton suggested replacing the holiday tree at the community center, adding it will not be until this fall. Mrs. Hodges stated Mr. Winton is having trouble hiring employees but is still looking. Mrs. Hodges went on to say that the borough needs to start making plans for a new garbage truck. Mrs. Hodges stated that although the trucks do not go far, they are constantly running and that there is formula that is used to calculate the actual miles adding one truck has 496,000 miles, one has 329,000 miles and the last one has 170,000 miles.

Mrs. Hodges complimented the trees in the downtown area adding they look nice along Union Avenue.

Councilman Davis reported that he attended the Board of Education meeting, adding they covered routine items. Mr. Davis stated that one "interesting" action was that the floor was open for public comments after action had already been taken. Mr. Davis also stated that more residents should attend, adding the next meeting is May 16<sup>th</sup> at 7:30 p.m.

Mr. Davis also reported at the Board of Education meeting it was reported that a proposal was put forward from the Manchester Board of Education adding it was called The Board of Education Information Committee Report; however, they went into close session, came out of closed session, and stated the report requires no action.

Mr. Davis went on to report that the Board of Education will be replacing the pre-school playground at the cost of about \$140,000, adding most of the cost will be covered by a grant. Mr. Davis stated that the Board of Education pointed out the landscaping of the playground was going to be completed through a shared service with the borough but have decided it would be more efficient to have the contractor perform the job and save the taxpayers money.

Mayor Robbins elaborated on the shared service saying it is his understanding that the assistant superintendent approached Mr. Winton and asked if the Borough's Public Work Department would assist with the landscaping. Mayor Robbins went on to say that when Mr. Winton approached him, he directed Mr. Winton to have the Board of Education make a formal request to the governing body to discuss, adding no request was made.

Mayor Robbins also elaborated on the Manchester Board of Education proposal saying that Manchester wanted to do a feasibility study for Lakehurst Elementary School to become an all pre-school building for both Manchester and Lakehurst and added the Lakehurst students would go to the Manchester Schools, this would be great for the Lakehurst students to socialize with the Manchester students. Mayor Robbins stated Council President Oglesby and himself met with the Lakehurst Board of Education President and Vice-President to ask why they turned down a feasibility study, it is a study that is not turned in to the state and a study that Manchester Board of Education has budgeted for and will pay the fee of \$19,000. Mayor Robbins also stated that Lakehurst Board of Education stated that the study will be turned in to the state and then there is a good possibility that Lakehurst will lose their state funding. Mayor Robbins further stated that they assured them that the study is an in-house study that is not reportable.

Councilman McCarthy stated that refusing to conduct the study does not show due diligence given the nature of "things" going on within the state and the push towards school districts to merge, Lakehurst Board of Education will lose control when that time arrives.

Council President Oglesby stated school districts in Ocean County have had massive budget cuts adding two-thirds of Lakehurst Board of Education's budget comes from outside sources, it is only a matter of time. Mr. Oglesby added that the Lakehurst Board of Education needs a plan in place for if, and when, they lose the funding they are receiving.

Mr. McCarthy reported that Police Chief Kline expects the new police car to be delivered this month. Mr. McCarthy also reported that all the steps the governing body requested for this Sunday's Tanker Task Force Drill have been covered. Mr. McCarthy stated that there was a joint meeting with all that are participating to cover procedures that will take place.

Mr. Oglesby asked if there was an after-action meeting post forest fire.

Mr. McCarthy responded he is not aware of any meeting adding he did speak with Fire Chief Dries immediately after, who informed him that the fire was 100% contained. Mr. McCarthy stated that an after-action meeting would probably be at the state level.

Mr. McCarthy further reported that the police department is almost "whole" again and Police Chief Kline does have a lifeguard for this summer.

MAYOR COMMENTS:

Mayor Robbins wished a Happy Mother's Day to all moms.

Mayor Robbins advised everyone the Town Wide Yard Sale is May 20<sup>th</sup> and added everyone can register at Borough Hill to be placed on the map.

COMMENTS FROM PUBLIC:

Bruce Margeson, 5 Geneva Road, gave kudos to the Fire Fighters and First Responders for risking their lives and added they did a fine job.

Mr. Margeson stated that now the weather is nice, many people are visiting Lake Horicon asking the borough to have the bathrooms open May 1<sup>st</sup>.

Mayor Robbins responded that he would reach out to Public Works Department Head Dave Winton to see if it is a possibility to have bathrooms ready before Memorial Day.

Mr Margeson thanked the governing body for all the work they do.

Mayor Robbins thanked Mr. Margeson as well.
